NZSTI is pleased to announce the call for proposals for the 2025 NZSTI Conference to be held in Te Whanganui-a-tara, Wellington on 13-14 September 2025. This year's theme, **Past, Present, Future: Shaping the Legacy of Translation and Interpreting** invites us to reflect on the evolution of our professions, delving into the milestones and lessons that have shaped the field, the dynamic challenges and innovations influencing our present, and the opportunities and aspirations that lie ahead. This theme celebrates the essential role of translators and interpreters in connecting cultures and communities, fostering collaboration and mutual understanding across time. It is a call to examine where we've been, where we are now, and where we could go—shaping the future of our work and its enduring impact on a rapidly changing world.

We invite T&I practitioners, professionals, researchers, academics, organisations, industry experts, service users and other stakeholders to submit their proposals, taking inspiration from (but not limited to) the following sub-themes:

- Innovations in crisis translation: responding to emergencies and global crises

- Supporting migrant and refugee communities through T&I

- Highlighting the role of T&I in promoting inclusion and diversity
- Enhancing professional wellbeing and support networks

• Shaping the future: Emerging voices and new directions

- Empowering the next generation of T&I practitioners: students and young professionals
- Advocacy and activism for language learning and policy change
- Imagining the future of T&I: trends, aspirations, and new possibilities

• Diverse Perspectives: Global and local T&I practices

- Amplifying underrepresented voices in T&I
- o Exploring the role of T&I practitioners as global citizens and cultural bridges
- o Integrating intercultural training into professional development
